

# Wanborough Parish Council

**Wanborough Parish Council is summoned to an Ordinary Meeting of the Parish Council to be held on Wednesday 20<sup>th</sup> of July at 7.30pm in Wanborough Village Hall.**

**Meeting started** 7:30pm

## **1. Minutes**

JH went through the minutes for the annual meeting and ordinary meeting held on 25<sup>th</sup> May 2022. These were approved and signed by the chairman.

## **2. Matters arising**

KS confirmed that the clerk's new laptop had been included in the insurance policy.

JH reported that the Big Lunch had been a great success; it had been good to see the Wanborough community celebrating the Jubilee in such style. JH said he was pleased to see the group photo in the recent edition of the Village News.

## **3. Update from SCC & GBC representatives**

KS read out an email received from TR.

MF announced that the A31 signage repairs were due to be carried out this week.

MF suggested a longer term solution to repairing the Wanborough signage that is repeatedly knocked down on the corner at the top of Westwood Lane; namely to replace it with a white "welcome gate" further down the hill and away from the corner. JH agreed with this idea as much more sustainable than just replacing the sign again in its current location. MF asked WPC to confirm to him in due course that it would like to proceed with this plan.

MF shared that he has a small amount of SCC community funding left for anyone working on suitable community projects.

MF confirmed that the double yellow lines by the Hogs Back Hotel would be replaced over the summer.

MF checked if we had received any correspondence on bus shelters. KS confirmed that WPC had not. MF to send through.

MF told WPC about an electric "request" bus service that had had a successful trial in Mole Valley area; MF said he would share more information as it had potential appeal for parishes like Wanborough.

MB asked MF if he could provide any help to deter motorcyclists racing along Westward Lane. MF will pick up this issue with the police. However, MF pointed out that if more people submitted email complaints, or called 101, then increased police awareness would eventually lead to a response. MF also mentioned the possibility of tackling this issue with noise recorders/cameras that were being trialled elsewhere.

#### **4. Planning and enforcement updates**

OC provided the following updates:

- The paramotors have stopped activity at Homestead Farm.
- Plot 4 has appealed the refusal against the electricity application: WPC has submitted an objection. Awaiting decision.
- On Plot D in the lower field, the large barn-type structure is in the process of being taken down.
- Plot F (horse stables) have requested a certificate of lawfulness for agriculture usage. This has no impact on the existing enforcement notice.
- In respect of potential solar panel installation to the east of East Flexford Lane, OC has received an invitation from Tour Limited for a meeting with WPC regarding the questions submitted by OC. OC invited to any other councillors who would like to join him.
